

# Certificate III in Makeup tradePLUS - SACE Stage 2



## About the Course

This course builds on the skills and knowledge gained in Certificate II and reflects the role of individuals who work as salon assistants and are competent in communicating in the workplace, interacting with and providing service to clients, and assistance to colleagues. They perform routine functions under direct supervision as part of a beauty therapy team. This is a full Certificate III qualification and can be used towards an ATAR.

## Pathways

After completing this course, individuals will be well-placed to seek employment in the industry.

## Prerequisite

Certificate II in Retail Makeup and Skin Care.

## Uniform Requirements

Students must adhere to all WHS requirements whilst undertaking training and Structured Work Place Learning (SWL). This includes the wearing of long black pants and covered low heel black shoes. RTTC will provide a black short sleeve tunic as part of the resource fee. A plain black cardigan may be worn during the cooler months.

Students must complete a minimum of 40 hours SWL.
